OKLAHOMA AFFORDABLE HOUSING

Trump's Budget Cuts \$7.4 Billion in HUD funds

President Trump's FY 2018 Budget cuts HUD funding by 15% compared to FY 2017. If enacted, this budget would cause a rise in homelessness, accelerate the decline of public housing infrastructure and curb affordable housing production. Across Oklahoma, Section 8 and Public Housing would see significant reductions¹ and CDBG and HOME would be completely eliminated:

2,803 Section 8 Voucher Households at Risk of Homelessness
Helps families afford private market rent.

-\$15,068,656 Public Housing Operating & Capital Funds
Ongoing maintenance and critical building repairs, essential to safe and healthy housing conditions.

-\$24,494,715 Community Development Block Grant (CDBG)
Provides flexible funding for community development & revitalization programs.

-\$9,959,097 HOME Investment Partnership (HOME)
Supports rental housing for extremely low-income families that the private market does not serve.

Trump's Rent Increase Proposal

President Trump's Budget proposes to increase HUD-assisted tenants' contributions from 30 percent of adjusted income to 35 percent of gross income and eliminate the payment of utility reimbursements.

- **\$1020 Average Annual Rent Increase** for households in HUD-assisted housing.²
- **89%** of OK households utilizing HUD rental assistance include **Children or Elderly or Disabled**.³

Affordable Housing Need

- **LOW-INCOME RENTERS**
*105,000 Severely Rent-Burdened OK Families pay more than half their income in rent each month.*⁴
- **GROWING ELDERLY POPULATION**
*Between 2015 and 2035, the US senior population will rapidly grow from 48 million to 79 million.*⁵
- **HOMELESS**
*In OK, there are 4,107 homeless individuals, including 358 veterans & 1,110 people in families with children.*⁶

Jobs and Economic Benefits At-Risk

In Oklahoma, from 1986-2014⁷ affordable housing development & preservation impact:

29,606 Homes | **33,455** Jobs | **\$3.19 Billion** Local Income | **\$1.26 Billion** Tax Revenue
